## How long will this take?

On average, estates that fall within this range are dealt with within 4-8 months. Typically, obtaining the grant of probate takes 8-12 weeks. Collecting assets then follows, which can take between another 8-12weeks. These time scales take into account the present delays at the Probate Registry due to the National circumstances arising in 2020. Once this has been done, we can distribute the assets, which normally takes up to 4 weeks.
